4. Presentations

4.1 Ingrid Janssen, Volunteer, Little Forests Durham

Re: Little Forests Durham Program

Ingrid Janssen provided a presentation regarding the Little Forests Durham Program. Highlights of the presentation included:

- information about the Little Forests Durham Program;
- the average size of a little forest, also known as a mini forest, and the steps taken to prepare the area for planting;
- details about the diversity of vegetation planted in a mini forest;
- a summary of the research and methodology of planting mini forests; and,
- the program's goals for 2025 including raising community awareness, participating in community events, working with community partners, and increasing the number of team members and volunteers.

A question and answer period ensued regarding:

- the criteria for selecting tree and shrub species for mini forests;
- whether pioneer species are considered suitable for mini forests;
- the categorization of weeds;
- the criteria for selecting planting sites;
- outreach opportunities to increase municipal awareness of the program;
- approximate expenditures to plant a mini forest;
- whether Little Forests Durham would register as a charity;
- collaborating with local schools to continue research into mini forests; and,
- details about the benefits of mini forests in urban spaces.

- increasing the availability of online platforms for the Committee to post sustainability and educational information for residents.
