5.1 2024 Accessibility Plan Update

Michele Cotton provided an update regarding the 2024 Accessibility Plan achievements which included:

- details about the Staff Working Group activities;
- the new Whitby Sports Complex;
- ongoing partnerships between advisory committees;
- the Wayfinding and Signage Project;
- the Accessibility Improvement Grant;
- collecting data on bench locations along Whitby's trail networks;
- the Home Sweet Home Festival;
- the Brock Street Redesign Project;
- a proposed seasonal tourism building and seating area at the Whitby Waterfront; and,
- installing electric vehicle charging stations at Town facilities.

5.2 Durham Region Accessibility Award Nominee

Michele Cotton provided details about the Durham Region Accessibility Award. Ms. Cotton requested feedback from the Committee regarding recipient nominations for Whitby's Durham Region Accessibility Award.

Discussion ensued regarding the criteria for nominating a business, person, or not-for-profit organization.
