Re: 2024 Biennial Community Survey Results

### Refer to Item 6.1, CAO 15-24

Erika Botond, Senior Manager of Communications & Creative Services, provided an introduction of the 2024 Biennial Community Survey conducted by Forum Research.

Sarah Lam, Research Director, and Lorne Bozinoff, President, Forum Research, provided a PowerPoint presentation regarding the 2024 Biennial Community Survey Results. Highlights of the presentation included:

- the goal of conducting a community survey to better understand the needs, expectations, priorities, and concerns of its residents;
- the survey methodology, participation rates, and margin of error;
- an overview of the community survey results, including top issues identified by residents;
- a summary of survey responses concerning satisfaction with living and working in Whitby, quality of life, quality of Town services, taxation, customer service, and the reliability and accuracy of information provided by the Town; and,
- participant demographics.

A question and answer period ensued between Members of Council, S. Lam, L. Bozinoff, and Staff regarding:

- whether the demographics of telephone survey respondents was representative of Whitby residents and strategies for ensuring the sample size captured all age groups;
- results of the Town's survey compared to similar surveys conducted by other municipalities;
- top priority issues facing Whitby residents according to the survey results;

- whether the priority of a new hospital is unique to Whitby when comparing similar survey results of other municipalities;
- whether the survey offers insight into residents' understanding of the distinct roles of various tiers of government;
- resident satisfaction with the current level of taxation in Whitby;
- clarification regarding the margin of error;
- the influence of external sources such as media on survey results;
- the comparison between online and telephone survey results;
- whether the telephone survey included both landline and cellphone numbers;
- the telephone survey response rate;
- a comparison between the Community Survey and Community Strategic Plan survey results; and,
- opportunities for improving overall resident satisfaction ratings.

6.2 PDP 36-24, Planning and Development (Planning Services) Department Report

Re: Naming of Mid-Block Arterial Road (MBA)

Roger Saunders, Commissioner of Planning and Development, and John Taylor, Senior Manager of Zoning and Regulation, provided an overview of the proposed Mid-Block Arterial Road (MBA) naming. Mr. Saunders explained that a street name is required to register approved Industrial Plans of Subdivision in proximity to Baldwin Street South with frontage along the mid-block arterial and to advance the construction of the proposed round-a-bout in a timely manner at Baldwin Street South and the new mid-block arterial road. Mr. Taylor advised that staff, the Town's consultant, and Fieldgate Developments had several meetings with First Nations representatives to discuss the process of naming rights.

A question and answer period ensued between Members of Council and Staff regarding:

- whether proposing an alternate street name to 'Kent Mills' may impact the construction and project timelines;
- whether 'Meadoway' is included on the approved Town of Whitby Street Name Registry and the relevance of proposed street names to Whitby residents;
- opportunities for additional consultation with First Nations representatives;
- whether the street name 'Meadoway' may cause confusion for residents given recent discussions regarding the Durham Meadoway Visioning Study;
- consideration of the street name 'Gathering Place';
- consultation with First Nations representatives regarding the proposed street name 'Kent Mills';
- clarification regarding the street names to be reviewed during the proposed additional consultation with First Nations representatives, as requested by Council;
- whether additional consultation with First Nations representatives will delay construction timelines;

- whether the street name 'Gathering Place' has been approved through an emergency services approval process at the Region of Durham and by the Ministry of Transportation;
- clarification on implications should Council defer consideration of Staff Report PDP 36-24 on construction timelines, and the impact on the Town's relationship with Curve Lake First Nation;
- details about the consultant from Candevcon retained to consult with First Nations, including the related costs;
- Council direction to Staff to obtain the Region of Durham's approval of the street name 'Gathering Place' to be used for additional roads; and,
- Council direction to Staff to provide a copy of the approved Town of Whitby Street Name Registry to First Nations representatives.
